Gross Domestic Product - 2015/16

I. Gross Domestic Product and its structure

In the fiscal year 2015-16, GDP at current market prices was estimated to be Rwf 6,139 billion, up from Rwf 5,631 billion in the previous fiscal year. The Services sector contributed 47 percent of GDP while the agriculture sector contributed 33 percent of the GDP. The industry sector contributed 14 percent of the GDP and 6 percent was attributed to adjustment for taxes and subsidies on products.

II. Growth rate by kind of activity1

In 2015/16, estimates calculated in 2011 prices shows that GDP was 6.5 percent higher in real terms compared to the previous fiscal year.

In this year, "Agriculture sector" grew by 5 percent and contributed 1.6 percentage points to the overall GDP growth. Activities in the "industry sector" increased by 4 percent and contributed 0.6 percentage points. "Service sector" increased by 8 percent and contributed 3.9 percentage points to the overall GDP.

III. Expenditure GDP

In the fiscal year 2015/16, private final consumption expenditure was 77 percent of the GDP while government final consumption expenditure was 13 percent. Gross fixed capital formation is estimated at 26 percent of GDP. Change in inventories is estimated at 1 percent of the GDP.

In this year, export increased by 11 percent, while imports increased by 13 percent.

IV. GDP Deflator

Based on 2011=100, the implied GDP deflator is 119, in 2015/16, compared to 116 in 2014/15
