Rebased estimates of GDP: An Explanatory note

The GDP publication of estimates of GDP for quarter 4, 2016 sees the introduction of updated information on the structure of the economy in Rwanda. The previously published estimates of GDP used 'industry weights' based on the levels of economic activity in 2011. In keeping with international guidance, NISR updates these weights as frequently as possible. In 2016 NISR developed a Supply and Use Table (SUT) for 2014, which is now used as the basis of the weights for aggregating components of GDP. The SUT is described in detail in a separate note.

The 2014 SUT provides more up-to-date and relevant estimates of the structure of the economy in Rwanda. In the new rebased series, growth in GDP has been kept unchanged for years up to and including 2012 (because the previous weights, for 2006 and 2011, are more relevant over that period). For 2013 and subsequent years, the new weights for 2014 have been applied to the detailed estimates of growth to produce the revised GDP series, in 2014 constant prices.

In current prices, the previously published level of GDP in 2014 was based on the 2011 SUT extrapolated using indicators of growth of value added in each industry. This extrapolated estimate for 2014 was 5,394.7 RWF billions. The revised level of GDP in 2014, based on the new SUT, is 5466.2 RWF billions, a revision of just +1.3%. This suggests that the indicators used to extrapolate the benchmark level of GDP have provided an unbiased estimate of GDP growth over the period 2011-2014.

Revisions to the GDP estimates

The use of the new estimates of value added from the 2014 SUT in estimating total GDP lead to some revisions to GDP growth from 2014. In addition, NISR has taken this opportunity to introduce some improvements to the methods and indicators used to extrapolate the base year levels. For example, the use of the data from NISR's Seasonal Agriculture Survey which began in 2014, and more complete information on the activities of the Telecommunications sector and General Government. NISR can provide more details of these improvements (see contact details, below).

Figure 1, and Table 1 in the annex, sets out the changes in the weights used to aggerate the industry series, comparing the 2011 SUT weights with the 2014 weights.




Figure 1: Shares of total GDP 2011 and 2014

As can be seen:

- The weight given the value added of the Agricultural sector has decreased from 32% in 2011 to 29% in 2014
- Food Crops accounted for 22% of total GDP in 2011, but just 17% in 2014.
- While the value added of the service sector, as a percentage of GDP, has remained unchanged at 47%, Trade & Transport services decreased in weight from 15% to 12%, while 'other services activities' increased from 31% to 35%.

The new weights lead to revised estimates of economic growth. Notably, they give greater weight than previously to many service sector activities. Since these activities have experienced faster economic growth in Rwanda over the period since 2013, this leads to higher estimated growth in GDP in 2014 and 2015 than previously published. Table 3 shows the contributions to the revisions to constant prices GDP growth from each economic activity (and taxes), comparing the previous estimates with the 2014 based estimates. In the first two columns, the sum of the contributions in each period equals the revision to growth in aggregate GDP. The final four columns show the previously published and new growth rates for each activity. The table shows, for example:

- Between 2013 and 2014, aggregate GDP was revised by +0.6 percent (from the previously published figure of 7.0% to 7.6% on the revised basis).
- Of this +0.6 increase, 0.2 percentage points (pps) were accounted for by the Food Crops sector. This increase largely reflects improved data based on NISR's Seasonal Agricultural Survey than in the previous estimates.
- Manufacturing activities also contributed to the upward revision in the 2014 annual growth rate, largely because of improvements to the data used to estimate Beverages and Tobacco production.
- There was an off-setting decrease in the contribution to the aggregate revision from the Wholesale and Retail trade sector, which reflects its reduced weight in the new estimates.

Estimated GDP growth in 2015 compared to 2014 was revised up by 1.9pps (the actual growth as revised from 6.9% to 8.9%, based on the unrounded estimates).
 +1.4 pps of this revision came from service sector components. In addition, the Construction sector contributed a further +0.4 pps to the overall revision, largely because of the use of an improved methodology for measuring the sector which now includes estimates of work in progress, in line with the standards set out in the United Nation's System of National Accounts 2008.

The changes affect the current price estimates of GDP as well as the constant price series. As such, the ratio of these two series, known as the 'GDP Deflator' (which provides an aggerate price index for each activity) have also been revised for the years 2014 and 2015. Table 3 shows the contributions to the aggregate GDP deflator from the revised industry estimates, as well as the previous and revised annual percentage change in the deflators for each industry. This shows, for example:

- A revision to the growth in the aggregate GDP deflator of -1.7 percentage points in 2015 compared to 2014 (in rounded terms the growth was revised from 1.7% on the previous basis and 0.1% on the revised basis).
- This revision results mainly from improvements in the methodology used to estimate output of the Education sector (accounting for -0.6 pps of the total revision), and also a revision to the estimated growth in the price of Food Crops (accounting for a further -0.5 pps).
