Balance of Trade

The deficit in the balance of formal trade in goods was US\$ 91.21 million in July 2017, an increase of 32.27 per cent when compared to the previous month of June. Year-over-year, the formal trade in goods deficit increased by 14.31 per cent on the deficit of July 2016.

Exports
