# **Gross Domestic Product - 2014**

## I. Gross Domestic Product and its structure

In 2014, GDP at current market prices was estimated to be Rwf 5,389 billion, up from Rwf 4,864 billion in 2013. The Services sector contributed 47 percent of GDP while the agriculture sector contributed 33 percent of the GDP. The industry sector contributed 14 percent of GDP, and 5 percent was attributed to adjustment for taxes less subsidies on products.

# II. Growth rate by kind of activity<sup>1</sup>

In 2014, estimates calculated in 2011 prices shows that GDP was 7 percent higher in real terms compared to 2013.

In this year, "**Agriculture sector**" grew by 5 percent and contributed 1.6 percentage points to the overall GDP growth. Activities in the "**industry sector**" grew by 6 percent and contributed 0.9 percentage points to the GDP growth. "**Service sector**" increased by 9 percent and contributed 4.3 percentage points to the GDP growth.

# III. Expenditure GDP

In 2014, private final consumption expenditure was 74 percent of the GDP while government final consumption expenditure was 15 percent. Gross fixed capital formation is estimated at 25 percent of GDP. Change in inventories is estimated at 1 percent of the GDP

In this year, imports increased by 7 percent at constant 2011 prices; exports increased by 4 percent.

# IV. GDP Deflator

Based on 2011=100, the implied GDP deflator increased by 3.6 percent from 111 in 2013 to 115 in 2014.

 $<sup>^{1}</sup>$  The adjustment for taxes less subsidies increased by 3 percent and contributed 0.1 percentage points of the total growth in 2014.
