SUMMARY

In the second quarter of 2015, Rwanda's total trade of US\$ **614.88** million, higher by 3 percent over the second quarter of 2014 was made up of exports worth of US\$ **94.82** million, imports worth of US\$ **470.60** million and re-exports valued at US\$ **49.46** million.

Total imports of Rwanda increased by 1.90 percent in the second quarter of 2015 when compared to the same quarter of 2014 (US\$ 470.60 million and US\$ 461.82 million respectively) and rose by 8.79 percent over the first quarter of 2015. Domestic exports reduced by 10.07 percent during the period of the second quarter 2015 over the same quarter of 2014 (US\$ 94.82 million and US\$ 105.43 million respectively) and reduced by 6.96 percent compared to the first quarter of 2015. Re-exports from Rwanda decreased by 15.67 percent in the second quarter of 2015 over the second quarter of 2014 (US\$ 49.46 million and US\$ 58.65 million respectively) and registered an increase of 30.61 percent over the first quarter of 2015.

For domestic exports side, the three top destinations were: Kenya, the Democratic Republic of Congo and Switzerland.

The top five destination countries of Rwanda's exports in the second quarter of 2015 totalized US\$ 58.54 million (60% of the total value of exports) while they totalized US\$ 64 million in the second quarter of 2014 (around 61 % of the total value of exports in that period)

The commodity groups with the largest increase in values on exports were: "Niobium, vanadium ores, tantalum and concentrates" (US\$ 17.16 million), "Other black tea (fermented) and other partly fermented tea" (US\$ 10.94 million), "Coffee, not roasted, not decaffeinated" (US\$ 10.57 million), "Tin ores and concentrates" (US\$ 8.27 million) and "Tungsten ores and concentrates" (US\$ 6.54 million).

For re-exports side, the top five destinations in the second quarter 2015 were: the Democratic Republic of Congo, the United Arab Emirates, Germany, Kenya and the United Kingdom.

The most re-exported commodity group was: "Motor Spirit (gasoline) premium" (US\$ 10.14 million) followed by "Gas oil (automotive, light, amber for high speed engines)" (US\$ 6.99 million), "Kerosene type Jet Fuel" (US\$ 6.15 million), "Vegetable fats and oils and their fractions" (US\$ 3.56 million) and "Aircraft engines" (US\$ 3.50 million)

For imports, there have been minor changes in top five origins of imports of Rwanda during the second quarter of 2015 in the extent that India replaced Uganda on the second place when compared to the first quarter of 2015. China, India, Uganda, Kenya and the United Arab Emirates form the top five countries of origin and totalized US\$ 270.07 million of imports (57% of the total value of imports) while in the second quarter 2014 they totalized US\$ 259.88 million (56% of the total value of imports in that concerned period).

The most imported commodity groups with the largest quarterly increases in values were: "Other sugar, not containing added flavouring or colouring matter" (US\$ 29.51 million), "Other portland cement" (US\$ 22.54 million), "Telephones for cellular networks or for other wireless" (US\$ 19.62 million), "Other medicaments in measured doses for retail sale" (US\$ 17.14 million) and "Vegetable fats and oils and their fractions" (US\$ 10.00 million).

Introduction

The second quarter 2015 (period from April to June) statistical report of Formal External Trade in Goods is compiled from raw data provided by Rwanda Revenue Authority (RRA) and treated by NISR using EUROTRACE DBMS and MS Access.

To collect and compile external trade statistics, NISR relies on the General Trade System under which the recorded aggregates include all goods entering or leaving the economic territory of a country with the exception of simple transit trade.

Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses.

Exports cover domestic exports defined as goods of national origin; that is, goods produced in the exporting country.

Re-exports which are exported in the same conditions as imported or after undergoing minor operations which leave them essentially unchanged and include re-exports from customs bonded warehouses.

Valuation of imports and exports: Imports are valued on a CIF (Cost, Insurance and Freight) basis while exports are valued on a FoB (Free on Board) basis.

Classification of commodities: The data is categorized by partner Country and the international standard classifications such as the Harmonized Commodity Description and Coding System (HS) and the Standard International Trade Classification (SITC), all linked to the national Customs Procedure Codes (CPCs).

Furthermore, the compilation of External Trade Statistics abides by the recommendations of the International Merchandise Trade Statistics, (IMTS-2010) of the United Nations Statistics Division (UNSD).

1. Overview of Rwanda Trade

There has been 3 percent increase in Rwanda's total trade in the second quarter of 2015 (US\$614.88 million) over the same quarter of 2014 (US\$ 598.20 million) and 7 percent increase when compared to quarter one of 2015 (US\$ 572.38 million).

Total imports have scored a share of 77 percent, exports contributed a share of 15 percent and re-exports contributed a share of 8 %.




Fig 1: Total Trade, 2013-2015Q2

Fig1 below serves to better illustrate the values of imports and total exports of Rwanda since 2013 on quarterly basis.

1.1 Overview of Domestic Exports

Domestic exports in the second quarter of 2015 amounted to US\$ 94.82 million showing a decrease of 6.96 percent compared to the first quarter 2015. This is mainly explained by decreases in the exports of "Other black tea (fermented) and other partly fermented tea" (0.10 percent), "Tin ores and concentrates" (0.28 percent) "Other unwrought gold (incl. gold plated with platinum), non monetary" (0.73 percent).

When comparing to the corresponding quarter of 2014, exports in the second quarter of 2015 decreased by 10.06 percent. This is mainly explained by decreases in values of "Niobium,

vanadium ores, tantalum and concentrates" (0.26 percent), "Tin ores and concentrates" (0.61 percent), "Whole hides and skins, of a weight per skin not exceeding 8 kg" (0.16 percent), "Pyrethrum" (0.47 percent).

1.2 Exports by Commodity

The top five most exported group of commodities were: "Niobium, vanadium ores, tantalum and concentrates" amounted to US\$ 17.16 million, "Other black tea (fermented) and other partly fermented tea" amounted to US\$ 10.94 million, "Coffee, not roasted, not decaffeinated" which amounted for US\$ 10.57 million, "Tin ores and concentrates" that amounted to US\$ 8.27 million and "Tungsten ores and concentrates" that was valued at US\$ 6.54 million.

1.2.1 Partner Country Analysis

The following countries received the largest Rwanda's exports during the second quarter of 2015: Kenya (US\$ 20.80 million), the Democratic Republic of Congo (US\$ 13.62 million), Switzerland (US\$ 11.85 million), Belgium (US\$ 6.57 million) and the United States of America (US\$ 5.69 million).

Subsequently, on quarterly basis, Table 1.1 illustrate that out of US\$ 94.82 million of Rwanda's total domestic exports, during the second quarter of 2015, the top five countries of destination accounted for US\$ 58.54 million (61.74 percent share over the total value of domestic exports registered in the second quarter of 2015).




Fig. 2. Exports to EAC Partner States, 2013-2015Q2

Figure 2 illustrates that Rwanda's domestic exports to East African Community Partner States (EAC) slightly decreased by 1.4 percent when compared to the same quarter of 2014 and reduced by 4 percent in comparison with the first quarter of 2015.

Kenya saw the largest increase in value of Rwanda's exports (US\$ 20.80 million from US\$ 18.73 million during the second quarter 2014).

Therefore, Kenya received 19.1 percent of the total value of domestic exports from Rwanda to the EAC Partner States (US\$ 20.80 million) during the second quarter of 2015 against US\$ 25.72 million. Uganda and Burundi followed Kenya and received domestic exports from Rwanda valued at US\$ 2.91 million and US\$ 1.69 million respectively.

2. Overview of Rwanda's Imports

Total imports in the second quarter of 2015 reached US\$ 470.60 million; registering increases of 8.78 percent over the first quarter of 2015 (US\$ 432.61 million) and increases of 1.90 percent when compared to the corresponding quarter of 2014 (US\$ 461.82 million).

Such increase is mainly due to imports of "Other sugar, not containing added flavoring or coloring matter" (1.58 percent)", "Other medicaments in measured doses for retail sale" (0.11 percent) and "Worn clothing and other worn article" (0.11 percent).

2.1 Imports by Commodity

During the second quarter of 2015, around 21 percent of Rwanda's total imports bill consisted of "Other sugar, not containing added flavouring or colouring matter" for US\$

29.51 million, at the first place and higher by 90 percent over the same quarter of 2014, "Other portland cements" which were valued at US\$ 22.54 million, higher by 49 percent when compared to the same quarter of 2014, "telephones for cellular networks or for other wireless" that accounted for US\$ 19.62 million, higher by 17 percent compared to the same quarter of 2014, "Other medicaments in measured doses for retail sale" amounted to US\$ 17.14 million, thereby increasing by 49 percent when compared to the same quarter of 2014.

The detailed table 6 hereafter attached to this report provides more insights on this sub-topic.

2.2 Partner Country Analysis (Origin of Imports)

In the second quarter of 2015, within the top five countries of imports' origin; three (3) are from Asia Continent, the major imports supplier and stood at US\$ 176.72 million, representing around 37.55 percent of total imports' value. Our imports originated mainly from the following countries: China (US\$ 85.53 million), Uganda (US\$ 56.62 million), India (US\$ 67.83 million), Kenya (US\$ 36.72 million) and the United Arab Emirates (US\$ 23.36 million).




Fig. 3. Imports from EAC Partner States, 2013-2015Q2

The following **Figure 3** shows that Rwanda's imports from the East African Community (EAC) Partner States in the second quarter of 2015 mainly originated, in huge values, from Uganda 48.4 percent of total imports from EAC followed by Kenya 31.4 percent and Tanzania 18.4 percent and Burundi 1.8 percent.

Furthermore, the Rwanda's imports bill from EAC Partner States stood at US\$ 116.97 million, representing 24.85 percent share over the total imports bill during the second quarter of 2015. A decrease of 3 percent over the first quarter of 2015 (US\$ 109.19 million in first quarter of 2015 and US\$ 116.97 million in the second quarter of 2015) has been observed. Rwanda's imports from EAC Partner States also increased in values by 5.92 % when compared to the same quarter of 2014 (US\$ 110.44 million in the second quarter of 2014, and US\$ 116.97 million in the second quarter of 2015).

3. Overview: Re-exports

In the second quarter of 2015, Rwanda's re-exports amounted to US\$ 49.46 million, representing an increase of 30.61 percent over the first quarter of 2015 (from US\$ 37.87 million in the first quarter to US\$ 49.46 million in the second quarter of 2015) and a fall of 15.67 percent when compared to the same quarter of 2014 (US\$ 58.65 million).

This is mainly explained by an increase in values of re-exports of "Motor Spirit (gasoline) premium" which stood at US\$ 9.10 million in the first quarter of 2015 and at US\$ 10.14 million in the second quarter of 2015; "Kerosene type Jet Fuel" which stood at US\$ 6.15 million in the first quarter of 2015 and at US\$ 5.60 million in the second quarter of 2014.

The major re-exported commodities for the second quarter of 2015 were: 'Motor Spirit (gasoline) premium' is worth of US\$ 10.14 million, 'Gas oil (automotive, light, amber for high speed engines)' worth US\$ 6.99 million, 'Kerosene type Jet Fuel' which amounted to US\$ 6.15 million, 'Vegetable fats and oils and their fractions' worth US\$ 3.56 million and 'Aircraft engines' worth of US\$ 3.50 million.

3.1 Re-exports by commodity

The commodity groups that dominated Rwanda's re-exports in the second quarter of 2015 include: "Motor Spirit (gasoline) premium" that amounted to US\$ 10.14 million, showing an increase in value of 30.64 percent over the second quarter of 2014 and an increase in value representing 11 percent when compared to the first quarter of 2015; "Gas oil (automotive, light, amber for high speed engines)" amounted to US\$ 6.99 million, expressing an increase of 70.38 percent against US\$ 4.10 million in the second quarter of 2014 and an increase of 15 percent when compared with the first quarter of 2015, "Kerosene type Jet Fuel" amounted to US\$ 6.15 million showing a decrease in value of 111.69 percent over the second quarter of 2014 (US\$ 2.91 million) and an increase of 10 percent when compared to the first quarter of 2015; "Vegetable fats and oils and their fractions" that amounted to US\$ 3.56 million, therefore accusing an increase of 71.67 percent over the second quarter of 2014 (US\$ 2.07 million) and an increase of 55 percent when compared to the first quarter of 2015 (US\$ 2.30 million).

3.2 Partner Country Analysis

The analysis of re-exports figures by country of destination for the second quarter of 2015 revealed that our fellow African countries were our main buyers. They have purchased 79.87 percent of Rwanda's total re-exports for the total value estimated at US\$ 39.51 million out of US\$ 49.46 million of the total value of Rwanda's re-exports in the second quarter of 2015. The Democratic Republic of Congo was the main destination, buying around 65.86 percent of Rwanda's total re-exports at the value estimated at US\$ 32.58 million.

The other major destinations of Rwanda's re-exports in the second quarter 2015 were the United Arab Emirates (8.14 percent), Germany (7.07 percent), Kenya (6.29 percent) and the United Kingdom (3.27 percent).

Not surprisingly, it is of great importance to point out that those top five destinations for Rwanda's re-exports during the second quarter of 2015 retain around 90.63 percent of the total value of total Rwanda's re-exports; they totalized US\$ 44.83 million out of US\$ 49.46 million.

The following table 3.2 serves to illustrate respective values per quarter per top five destination of Rwanda's re-exports.

Rwanda's re-exports to EAC Partner States decreased by 81.8 percent in value terms during the second quarter of 2015 compared to the second quarter of 2014 (US\$ 4.79 million and US\$ 26.34 million respectively). Secondly, revenues from re-exports to this region back dropped by 10 percent in value terms when compared to the first quarter of 2015 (US\$ 4.79 million and US\$ 5.34 million). Figure 4 serves to better illustrate the above described status.

4. Trade with Selected Regional Economic Organizations

During the second quarter of 2015, Rwanda's total trade with COMESA Member States attained US\$ 189.07 million against US\$ 193.48 million registered in the same quarter of 2014 and against US\$ 179.75 million registered in the previous quarter of 2015; that is 2.3 percent decrease and 5.2 percent increase respectively. There were no change in values of quarterly exports comparing to the same quarter of 2014 but reduced by 4 percent when compared to the exports figure registered during the first quarter of 2015 (US\$ 39.25 million

during the second quarter of 2015, US\$ 39.37 million in the second quarter of 2014 and US\$ 40.98 million in the first quarter of 2015).

Moreover, the quarterly value of imports from COMESA Member States increased by 6 percent against the same quarter of 2014 (US\$ 111.05 million against US\$ 104.93 million) and also increased by 7 percent when compared to the first quarter of 2015 (US\$ 104.08 million).

On the re-exports side, Rwanda registered revenues estimated at US\$ 38.77 million during the second quarter of 2015 in COMESA Member States; accusing then a backdrop of 21 percent in value terms against the same quarter of 2014 (US\$ 49.18 million) and an increase of 12 percent when compared to the first quarter of 2015 (US\$ 34.70 million). Thus, a negative trade balance of US\$ 33.03 million has been registered during the second quarter of 2015 whereas a negative trade balance of US\$ 16.39 million has been registered during the second quarter of 2014. Likewise, US\$ 28.40 million has been registered as a negative trade balance with COMESA Member States during the first quarter of 2015.

Total exports to Communauté Economique des Pays de Grands Lacs (CEPGL) Member States (Burundi and the Democratic Republic of Congo), during the second quarter of 2015 stood; at US\$ 49.44 million, against imports of US\$ 4.87 million. The trade in goods surplus with CEPGL member states worked out at US\$ 44.57 million while it was US\$ 38.84 million during the same quarter of 2014 and US\$ 42.31 million in the first quarter of 2015.

For SADC Member States, Rwanda's total trade attained US\$ 87.28 million during the second quarter of 2015 while it totalized US\$ 67.75 million in the second quarter of 2014 and US\$ 80.63 million during the first quarter of 2015. The quarterly exports decreased by 16 percent over the same quarter of 2014 (US\$ 14.15 million and US\$ 16.88 million respectively).

The total imports from SADC Member States increased by 40 percent in the second quarter of 2015 over the same quarter of 2014 (US\$ 40.53 million and US\$ 28.78 million respectively). An increase of 48 percent of the value of Rwanda's re-exports to SADC Member States has been registered during the quarter two of 2015 over the same quarter of 2014 (US\$ 32.60 million against US\$ 22.09 million respectively).

Consequently, a trade balance surplus of US\$ 6.22 million in the second quarter of 2015 was registered while it was at US\$ 10.18 million in the same quarter of 2014 and US\$ 9.76 million in the first quarter of 2015.

Trade in goods with the European Union (EU) in the second quarter of 2015 totalized US\$ 84.57 million against US\$ 97.55 million registered in the same quarter of 2014 and US\$ 86.87 million in the first quarter of 2015. That is 13 percent decrease over the same quarter of 2014 and 3 percent decrease when compared to the first quarter of 2015.

The quarterly exports to EU Member Countries decreased by 43 percent when compared to the same quarter of 2014 (US\$ 11.41 million while US\$ 20.08 million respectively). The total value of imports from EU decreased by 3 percent during quarter two of 2015 over the same quarter of 2014 (US\$ 67.99 million and US\$ 69.92 million respectively). Re-exports to EU also decreased by 32 percent during the second quarter of 2015 over the same quarter of 2014 (US\$ 5.17. million and US\$ 7.56 million respectively).

Thus, Rwanda's trade with EU registered a negative trade balance of US\$ 51.41 million during the second quarter of 2015 while it has showed a negative balance of US\$ 42.28 million in the same quarter of 2014 and US\$ 48.03 million in the first quarter of 2015.
