## **Gross Domestic Product - 2015**

#### I. Gross Domestic Product and its structure

In 2015, GDP at current market prices was estimated to be Rwf 5,837 billion, up from Rwf 5,395 billion in 2014. The Services sector contributed 47 percent of GDP while the agriculture sector contributed 33 percent of the GDP. The industry sector contributed 14 percent of GDP, and 6 percent was attributed to adjustment for taxes less subsidies on products.

# II. Growth rate by kind of activity<sup>1</sup>

In 2015, estimates calculated in 2011 prices shows that GDP was 6.9 percent higher in real terms compared to 2014.

In this year, "**Agriculture sector**" increased by 5 percent and contributed 1.5 percentage points to the overall GDP growth. Activities in the "**industry sector**" increased by 7 percent and contributed 1 percentage points to the GDP growth. "**Service sector**" increased by 7 percent and contributed 3.7 percentage points to the GDP growth.

## III. Expenditure GDP

In 2015, private final consumption expenditure was 78 percent of the GDP while government final consumption expenditure was 12 percent. Gross capital formation is estimated at 26 percent of GDP.

In this year, imports of goods and services increased by 9 percent at constant 2011 prices; exports of goods and services increased by 10 percent.

### IV. GDP Deflator

Based on 2011=100, the implied GDP deflator increased from 115 in 2014 to 116 in 2015.
