CONSUMER PRICE INDEX (CPI) August 2010

The National Institute of Statistics of Rwanda is very pleased to deliver to users the Consumer Price Index (February 2009=100). The All Urban CPI is regarded as the headline index, producing the official inflation rate.

The CPI is published every month by the 15th

All Urban Index:

In August 2010 the All Urban general index is established at 103.5 (103.53) this stands for an increase of 0.07% over the previous month which was 103.5 (103.45). In annual change it increased by 1.96% compared to 3.01% in the previous month. This gives a general inflation rate by an annual average of 4.1% during the month of August 2010.

The underlying inflation rate (excluding fresh food and energy) is decreased by (-0.31%) if compared to the previous month and increased 0.85% on annual change. The annual average underlying inflation rate is + 2.5% in August 2010 down from the previous month (+2.8%).

All Rural Index:

In August 2010 the All Rural general index is established at 101.1 this stands for an increase of 1.56% over the previous month which was 99.5. In annual change it increased by (-3.04%) compared to (-4.78%) in the previous month.

All Rwanda Index:

In August 2010 the All Rwanda general index is established at 101.9 this stands for an increase of 1.04% over the previous month which was 100.8. In annual change it decreased by (-1.39%) compared to (-2.22%) in the previous month.

In August 2010 the All Urban general index is established at 103.5 (103.53) this stands for an increase of 0.07% over the previous month which was 103.5 (103.45). In annual change it increased by 1.96% compared to 3.01% in the previous month. This gives a general inflation rate by an annual average of 4.1% during the month of August 2010.

The underlying inflation rate (excluding fresh food and energy) is decreased by (-0.31%) if compared to the previous month and increased 0.85% on annual change. The annual average underlying inflation rate is + 2.5% in August 2010 down from the previous month (+2.8%).


The increase in the consumer prices index of 0.07% is attributable primarily to the increase in Food and non-alcoholic beverages (0.18%) and Alcoholic beverages and Tobacco (1.42%).


It is noted that the increase of 0.18% in prices of Food and non-alcoholic beverages is primary attributable to the increase of 0.98% of Vegetables.

In annual change, the increase in the general index of 1.96% is mainly due to the rising prices of Food and non-alcoholic beverages (1.53%) and Transport (3.71%) which contributed +0.54% and +0.47%. respectively.

The 'local goods' increased by 2.43% on annual change with a monthly variation of 0.17%, while prices of the imported products increased by 0.10% on annual change with a monthly change of -0.30%.

The prices of the fresh products had a positive annual change of 6.46% between August 2010 and August 2009.






Evolution (over 12 months) of the rate of inflation (%) (1)

METHODOLOGICAL NOTICE

The Consumer Price Index (CPI) is a measure of the average change over time of goods and services purchased by households. The CPI uses a Modified Laspeyres formula to calculate the index. The reference population for the CPI consists of all households, urban and rural, living in Rwanda.

The household basket includes 1,136 products observed in many places spread all over the administrative centers of all provinces in Rwanda. All kinds of places of observation are selected: shops, markets, services etc. More than 29,200 prices are collected every month by enumerators of the National Institute of Statistics of Rwanda and of the National Bank of Rwanda.

The index reference, or base, for the CPI is February 2009.

The weights used for the index are the result of the Household Living Conditions Survey (EICV II) conducted in 2005-2006 with a sample of 6,900 households.

How to Interpret the CPI

Movements of the indexes from one month to another usually are expressed as percent changes rather than changes in index points. The level of the index (relative to its base period) affects index point changes, but it does not affect percent changes. The following example illustrates how to calculate percent changes:

Index point change
