1. Summary

This is the monthly publication of the Producer Price Index (PPI) for the month of August 2019.

- > General Producer Price Index increased by 12.82 percent on annual basis
- > Local Producer Price Index increased by 19.41 percent on annual basis
- Export Producer Price Index decreased by 6.73 percent on annual basis
- > General Producer Price Index decreased by 1.87 percent on monthly basis
- > Local Producer Price Index decreased by 2.34 percent on monthly basis
- Export Producer Price Index decreased by 0.33 percent on monthly basis




Figure1. Annual PPI for All Rwanda, local products and exports

2. Introduction

The Producer Price Index (PPI) measures the average change over time in prices received by domestic producers for the production of their goods and services. The Producer Price Index for Rwanda is published on a monthly basis.

It presents price changes for all combined products, products for local sales and that for exports. It covers a sample of 114 establishments and 402 products spread countrywide, both in Kigali City and in rural areas.

The Producer Price Index survey is conducted jointly with the National Bank of Rwanda. It now covers mining, manufacturing and energy.

3. General Producer Price Index

Table 2 below presents the percentage changes on monthly and annual basis.

General PPI increased by 12.82 percent in August 2019 compared to the same month of 2018. This is mainly due to an increase of 90.59 percent in price water supply activities' and an increase of 4.05 percent in manufacturing, offset by a decrease of 20.03 percent in the prices of mining and quarrying.

The monthly general PPI decreased by 1.87 percent compared to July 2019. This was mainly due to a decrease in prices of mining and quarrying by 9.82, and by 1.35 percent in the prices of manufacturing.

4. Local Producer Price Index

The table 3 below presents the percentage changes on monthly and annual basis.

Local PPI increased by 19.41 percent in August 2019 compared to the same month of 2018. This was mainly due to an increase of 90.59 percent in prices of water supply activities, and 4.23 percent in prices of manufacturing.

The monthly local PPI decreased by 2.34 percent compared to July 2019, mainly due to a decrease 3.09 percent in the prices of manufacturing.

5. Export Producer Price Index

The table below presents the index and the percentage changes on monthly and annual basis.

Export PPI decreased by 6.73 percent in August 2019 compared to the same month of 2018. This was due to a decrease in mining of other non-ferrous metal ores and manufacture of coffee by 20.03 and 14.55 percent respectively, and an increase in manufacture of other chemical products and manufacture of tea by 18.72 and 8.69 percent respectively.

The monthly export PPI decreased by 0.33 percent compared to July 2019. This was due to a decrease in mining of other non-ferrous metal ores by 9.82 percent, and an increase in manufacture of tea, and manufacture of other chemical products, and manufacture of coffee by 10.46, 9.50 and 2.21 percent respectively.

6. Technical note on PPI

The Producer Price Index (PPI) measures the average change over time in the prices received by domestic producers of goods and services which are output of production or enter in the production process.

NISR publishes PPI data for Mining, Manufacturing and Energy, and it will continue to be published monthly, about 4 weeks following the month under review.

The establishments are classified according to ISIC rev. 4; and the classification is determined by their main output.

The weights used in the PPI for Rwanda refer to the value of output (turnover without taxes) of establishments as reported in the 2011 Manpower survey collecting data for the year 2010, which constitutes the reference base period for the PPI calculation (December 2010). NISR plan to rebase the PPI using the weights as reported in establishment census 2017.

The point of pricing is the establishment. The price is the selling price received by the producer for the selected product as it leaves the factory gate. In general, prices are collected each month from the selected establishment by considering the mid-point of

each month of the month under review.

The formula used in the PPI calculation is the geometric modified Laspeyres
